Japanese Minister of Foreign Affairs embarks on Southeast Asia tour

The Japanese Minister of Foreign Affairs, Toshimitsu Motegi, embarks on an extensive tour of Southeast Asia, offering medical assistance to help countries contain the spread of the COVID-19. Agreements are already in place for Japan to provide hospital beds and ambulances to some members of the Association of Southeast Asian Nations (ASEAN). In July, Japan said it will provide the equivalent of 11.6 billion yen (\$109 million) in medical equipment and other supplies to five countries along the Mekong River - Cambodia, Laos, Myanmar, Thailand and Vietnam.

The seventh round of negotiations between the European Union and the United Kingdom starts in Brussels

The seventh round of negotiations between the European Union and the United Kingdom takes place from 18 to 21 August 2020, in Brussels. The latest round of negotiations between the EU and UK on their future relationship resulted in no breakthrough on key sticking points. If a deal is not reached, trade rules will revert to those set by the World Trade Organization. As the UK and the EU continued talks on their relationship after a post-Brexit transition period runs out at the end of 2020, there are hopes that a final agreement could be ready for an October 15-16 EU leaders' summit.

Can an agreement between the EU and UK still be reached by October?

The lack of access and restrictions placed by Governments has resulted in communities, civil society and local NGOs being the frontline of the response.

Women Entrepreneurs Finance Initiative invests in over 15,000 women-led businesses amidst COVID-19 crisis

The Women Entrepreneurs Finance Initiative (We-Fi) announces its third funding allocation comprising \$49.3 Million - expected to benefit over 15,000 women-led businesses and mobilize about \$350 million of additional public and private sector resources. We-Fi's latest round of allocations addresses the needs of women entrepreneurs created by the COVID-19 crisis, and encourages innovation and digital development, partnership development and the use of results-based mechanisms to facilitate greater access to financing for women entrepreneurs.

USA attempts to shut China out of shaping APEC data protection

The USA proposes separating a key international framework for data protection from the Asia-Pacific Economic Cooperation (APEC) forum. APEC's Cross-Border Privacy Rules (CBPR) system is a certification that companies can join to prove they meet internationally recognized data protections, allowing them to transfer such personal information as names and payment histories across borders without the onerous requirements that normally apply. By moving the framework out from under APEC, of which China is part, the USA is seen trying to keep valuable data from making its way to Beijing.
